AMENDMENT TO THE DECLARATION OF THE

COVENANTS, CONDITIONS AND RESTRICTIONS OF THE HERITAGE MEADOWS RECREATIONAL ASSOCIATION

KNOW ALL MEN BY THESE PRESENTS, the the undersigned, constituting all of the Owners of the Lots and Living Units platted within the exterior boundaries of Heritage Meadows, excepting Lots 1 through 4 and 34 through 37 therefrom, a subdivision of a part of the County of Boulder, according to the recorded plat thereof on file in the office of the County Clerk and Recorder of Boulder County, Colorado, for the use and benefit of themselves and all persons claiming or to claim any part of the above-described real property, by, through, or under them, hereby declare and agree that the Declaration of Covenants, Conditions and Restrictions of The Heritage Meadows Recreational Association dated May 31, 1979, and recorded on Film 1065 as Reception No. 340128 in the office of the County Clerk and Recorder of Boulder County, Colorado, shall be and that said document is hereby amended in the following particulars, to wit:

- 1. ARTICLE IV, Section 4 (b) is amended to read in its entirety as follows:
- (b) Non-Resident Membership. Every person or entity who is not a record owner of a fee or undivided fee interest in any Lot which is subject by covenants of record to assessment by the Association, but who has purchased a membership in the Association from the Declarant or other Non-Resident Member shall have a Non-Resident Membership in the Association. If more than one person holds an interest in such Non-Resident Membership, then all such persons shall be Non-Resident Members; however all such members must be members of the same immediate family. There shall be allowed a maximum of 50 Non-Resident Memberships in the Association.

That in all other respects said Declaration of Covenants, Conditions and Restrictions of The Heritage Meadows Recreational Association dated May 31, 1979, and recorded May 31, 1979, on Film 1065 as Reception No. 340128 in the Boulder County records shall remain in full force and effect.
